

**AGREED MINUTES OF DISCUSSION ON AIR SERVICES
BETWEEN THE DELEGATIONS OF THE GOVERNMENTS OF
ICELAND AND UNITED REPUBLIC OF TANZANIA**

Representatives of the Government of Iceland and the Government of the United Republic of Tanzania, met during the ICAN2025 in Punta Cana, Dominican Republic on 12 November 2025 to discuss matters related to air services between Iceland and Tanzania.

The negotiations were held in a cordial and friendly atmosphere, and both delegations expressed their desire to further promote their aeronautical relations in a spirit of cooperation and complete understanding for their mutual benefits.

The list the delegations is attached herewith as **Appendix I**.

The delegation of the United Republic of Tanzania proposed the inclusion of a new Article in the current Air Services Agreement (ASA) between the Republic of Iceland and the United Republic of Tanzania, related to exchange of Notices and Correspondences.

The delegation of the Republic of Iceland agreed the proposal but proposed that the exchange of the said correspondences should not necessarily be through diplomatic channel, as most of the correspondences are operational.

Both delegations discussed the proposal in detail and agreed not to introduce the new Article at this stage.

The delegation of the Republic of Iceland further informed the delegation of the United Republic of Tanzania that, Iceland had completed its internal processes related to the signing of the ASA.

The delegation of the United Republic of Tanzania informed the delegation of the Republic of Iceland that the Government of United Republic of Tanzania is at the final stages of its internal processes for signing of the ASA.

Both delegations agreed to expedite the remaining processes related to the ASA with a view to signing it by end of the first half of 2026.
